Merrill Krabill is an artist and educator at Goshen College. Besides the importance of educating the next generation of artists, that environment, seeing young artists engage the world of visual communication with fresh eyes, continually opens new possibilities for him.



In the summer of 2005 Krabill was

an Artist-in-Residence at Togei no mori (Shigaraki Ceramic Cultural Park). The opportunity to work, travel, and visit with artists in Japan has had a lasting impact on his work.

Krabill stated, "I have spent much of my career as an artist and as a professor sorting out what is meaningful in my work (and for students, in theirs). In a presentation to other artists I hope the path I have made sorting that out might be useful as other artists create their own paths."

All artwork must be ready to hang with wire. See proper hanging method on the nia-art.org website. Artwork content must be appropriate for a family gallery space. The Northern Indiana Artists or the Unitarian Church will not accept financial liability for accidents or loss.

Dues must be current to participate in any NIA show. If your dues were not current by (March 1, 2024) you will need to pay \$35 before entering. Pay on-line at nia-art.org or mail your dues to NIA Treasurer, PO Box 906, South Bend, IN 46624.
